CEASE AND DESIST ORDER

The Alabama Securities Commission ("Commission"), having the power to administer and provide for the enforcement of all provisions of Title 8, Chapter 6, Code of Alabama 1975, the Alabama Securities Act, upon due consideration of the subject matter hereof, and having confirmed information of the offer and sale of securities into, within, or from the State of Alabama, has determined as follows:

RESPONDENTS

1. RESPONDENT HAROLD R. FETTER (RESPONDENT "FETTER") is represented to be the Acting Secretary/Treasurer of RESPONDENT THE ALBERT SCHWEITZER SOCIETY USA, INC. with a business address of 265 Kimbarry Drive, Dayton, OH 45458. RESPONDENT FETTER also has a business address of P.O. Box 752073, Dayton, OH 45475-2073.

2. RESPONDENT FRANCIS P. HAVEY (RESPONDENT "HAVEY") is represented to be the Managing Director of RESPONDENT JMJ CORPORATION, N.V., ET AL with a business address of 8777 West Forest Home Avenue, Milwaukee, WI 53228.

3. RESPONDENT THE ALBERT SCHWEITZER SOCIETY USA, INC. (RESPONDENT "ALBERT SCHWEITZER"), is represented to be a non-profit organization with a business address of 265 Kimbarry Drive, Dayton, OH 45458. RESPONDENT ALBERT SCHWEITZER also has a business address of P.O. Box 752073, Dayton, OH 45475-2073.

4. RESPONDENT JMJ CORPORATION, N.V., ET AL ("JMJ CORPORATION"), is represented to coporation with a business address of 8777 West Forest Home Avenue, Milwaukee, WI 53228.

STATEMENT OF FACTS

5. The Commission is in receipt of information that RESPONDENTS FETTER, and HAVEY engaged in the offer and/or sale of investment contracts involving interests in an offshore investment loan program of RESPONDENTS ALBERT SCHWEITZER and JMJ CORPORATION, to Alabama residents, that were neither registered nor exempt from registration in the state of Alabama.

8. Review of the files of the Commission, disclosed no record of registration of RESPONDENTS FETTER, HAVEY, ALBERT SCHWEITZER or JMJ CORPORATION, as securities agents or dealers in the state of Alabama

9. Review of the files of the Commission, disclosed no record of registration, or exemption from registration, of the securities of RESPONDENTS ALBERT SCHWEITZER and JMJ CORPORATION.

CONCLUSIONS OF LAW

10. RESPONDENTS FETTER, HAVEY, ALBERT SCHWEITZER and JMJ CORPORATION, are not registered as securities agents or dealers in the state of Alabama.

11. Transacting business in the State of Alabama as a securities agent or dealer while unregistered is a violation of § 8-6-3(a), Code of Alabama, 1975.

12. The securities of RESPONDENTS ALBERT SCHWEITZER and JMJ CORPORATION, sold by RESPONDENTS FETTER and HAVEY, as set forth in paragraph 5, above, are not registered, nor exempt from registration in the state of Alabama.

13. The sale of unregistered, non-exempt securities into, within, or from the state of Alabama is a violation of § 8-6-4, Code of Alabama, 1975.

This Order does not prevent the Alabama Securities Commission from seeking such other civil or criminal remedies that are available to it under the Alabama Securities Act.

This Order is appropriate in the public interest for the protection of investors and consistent with the purpose of the Alabama Securities Act.

ACCORDINGLY, IT IS HEREBY ORDERED that, RESPONDENTS HAROLD R. FETTER, FRANCIS P. HAVEY, THE ALBERT SCHWEITZER SOCIETY USA, INC., and JMJ CORPORATION, N.V., ET AL, immediately CEASE AND DESIST from further offers or sales of any security into, within, or from the State of Alabama.
